



Terms and conditions

2022 Pascoe Vale Road – Albion Street competition

How to enter

1. The Greater Western Water Corporation (GWW) 2022 Albion Street competition (**competition**) is open to individuals and entities who are a registered GWW residential or business account owner (**eligible entrant**).
2. An eligible entrant can submit their details for entry into the competition from around their home or business via the form on the competition page on GWW's YourSay platform.

3. Entrants will be asked to register for updates by completing the sign-up form in order to be allowed to submit an entry. Entrant's first name and suburb will be visible to the public
4. The competition will run from 7.30am Wednesday 19 October to Wednesday 26 October 2022 at 5.30pm After the end of the competition period, GWW will draw a winner from all entries submitted during the previous week and select one as the weekly winner.
5. The final winners will be announced on 28 October 2022.
6. Three winners will be drawn. First draw will win \$100 dinner voucher to Primrose and Vine. Second draw will win a voucher provided by Bam Corner Shop. Third draw will win a food hamper from Primrose and Vine. GWW will contact each winner to inform them as the end of the competition period.
7. The Competition will run from 7.30am (AEST) on 19 October 2022 and will close at 5.30pm AEST on 26 October 2022 (**competition period**).
8. A director, manager, employee, officer or contractor of GWW and their immediate families are not allowed to enter the competition. "Immediate families" means:
 1. spouse or domestic partner, or
 2. parent, child or sibling (whether natural, half, step or by adoption) whether or not they reside in the same household.
9. An eligible entrant can only enter once in each competition week. Eligible entrants can enter each week of the competition, but their subsequent water saving tips must be different each week they enter. All entrants warrant that the information that they provide is their own work and does not breach the intellectual property rights of any other person or entity.

The Prize

1. There are up to three (3) x prizes to be won.
2. GWW will award each winners prize via registered post or courier to a prize winner's nominated address.
3. A prize winner is deemed to have accepted these Terms and Conditions upon acceptance of the Prize.
