This Privacy Statement applies to the Your Say online engagement site with the domain name yoursay.gww.com.au ("website"). Your Say is operated by Harvest Digital Planning on behalf of Greater Western Water.

We trust this Privacy Statement will assure you that we have taken your privacy and security concerns into account when you use this website and have addressed these requirements appropriately. In this Privacy Statement the expression "Personal Information" is used to refer to information or an opinion about an individual whose identity is apparent or can be reasonably ascertained from the information or opinion. Our handling of Personal Information collected in this website is also governed by our **Privacy Policy.** Our collection, use and disclosure of your Personal Information is regulated by the Victorian Privacy and Data Protection Act 2014. This Privacy Statement applies to all users who access the website. A user who accesses the website will be deemed to have agreed to comply with this Privacy Statement, Terms of Use and Moderation Policy.

We will post any changes to this Privacy Statement on the website, so we encourage you to check this Privacy Statement from time to time. Any information collected under this current Privacy Statement will be handled in accordance with this Privacy Statement. After any changes take effect, all new information collected, if any, will be subject to the revised Privacy Statement.

## **Collection of Personal Information**

To make comments in current and active projects on the website, users may be asked to create an account for which we will collect some Personal Information. You may browse the website and read information about the projects without providing any Personal Information.

## Sign-up (optional)

We collect information from you when you sign-up for Your Say. Required information includes:

- Username (this is published on the site alongside any public comments you make)
- email address (this will not be made public)
- Postcode
- Categories of interest
- Locations of interest



- If you would like to be notified by email of new projects that match your interests
- If you would like to receive our newsletter

By providing an email address you help us protect the integrity of the discussion from individuals and groups who may attempt to unduly influence the outcomes of the consultation process.

If you sign-up to receive e-newsletters and updates, the email address you provide will be used by Greater Western Water to send you this information. You can unsubscribe from these updates at any time.

## Demographic information (required on some project pages)

We will ask demographic questions when you sign-up to some individual projects or want to provide feedback. This will help us determine whether we are getting a diverse cross-section of participants.

These questions will vary from project to project.

### Information Use and Disclosure

Greater Western Water and Harvest Digital Planning Pty Ltd will not use or disclose Personal Information collected through the website for purposes unrelated to the purpose for which it is collected unless such use or disclosure is required or authorised by law, or with your consent.

We collect Personal Information to help us to provide services requested by individuals. Some related purposes for which Personal Information may be used and disclosed include:

- purposes related to planning, market research, service development, security, testing and risk management;
- purposes connected with the operation, administration, development or enhancement of the website;
- where City West Water suspects that fraud or unlawful activity has been, is being or may be engaged in.

## **Cookies**

The website uses "cookies" (small data files sent to your computer) so you do not need to enter your login details more than once during the same Internet session. These cookies do not collect Personal Information and are only used at the time that you log on and only for that Internet session. Cookies from the website will not be stored permanently on your computer.

#### **Collection of site visit data**

This website's web-server automatically collects and stores anonymous information for statistical and system administration purposes only:

your server (or IP) address



- the day and time you visited the site
- the pages you visited on our site
- the address of the last page you visited
- the operating system you are using
- rough geographic location (down to the city)
- language (e.g. American English)
- internet service provider (e.g. Telstra)
- the type of browser and version you are using.

To the extent that this data could make you identifiable, Greater Western Water will not attempt to identify individuals from the records the server automatically generates unless necessary to investigate a breach of law or regulation.

### **Collection of User Feedback**

We collect User Feedback via the following feedback tools:

- comments and votes in forums
- stories
- surveys
- · quick polls.

We use this information to help inform the development of our strategies, plans, initiatives and services to help shape how we deliver services to you now and into the future.

All User Feedback may be published in publicly available reports at the end of the consultation period.

### **Publicly available information**

Publicly available information is limited to your username and any comments you leave under

that name in the forums or other feedback tools on the website (that requires you to log in to participate).
